





CEO REPORT

On behalf of the Board of Trustees, CEO-Luis A. Reyes Jr., the management and employees of Kit Carson Electric, Kit Carson Energy, and Kit Carson Telecom, it has been our distinct pleasure serving our members in 2016. The Kit Carson family of companies has made and continues to make great strides in our territory, in providing the goods and quality of life services to our members have come to rely on. In keeping our focus and core values tied to the Cooperative spirit all of our successes could not have been possible without the dedication of our employees and most importantly the continued support from "YOU" our members. Thank you all for a successful year, we will continue to work hard on your behalf.

Kit Carson Electric Rate Case and associated Operations/Maintenance Overview

In 2016 KCEC embarked on several successful ventures. One of the most notable was the successful exit of our 2040 contract with Tri-State, unilaterally KCEC secured a new power supplier, Guzman Energy and now our members have a 10 year short term fixed cost of power purchase contract, and a plan to develop 35Mw's of Solar Power by 2022, which will allow KCEC generate 100% of its year round day time power supply from the sun. KCEC was also successful in negotiating our much needed rate increase which is tied directly to fixed costs and system reliability. Overhead line modernization and maintenance was one of the key components and need for the rate increase. KCEC deploys an extremely aggressive tree trimming program which greatly protects member's lives, properties and greatly mitigates the risk of forest fires. We continue to upgrade the electric grid for our customers that we serve both in new developments and by replacing existing aging infrastructure. As communities and local governments call for more underground services these vital services increase cost in our operations, but also provides greater access to electric service and greatly improves system reliability.

CEO REPORT

Other driving factors include continuing increases in property taxes, tribal taxes, cost of business expenses, kilowatt hour (kWh) reduction due to energy efficiency, lack of community growth and the large kWh loss of the Chevron Mining load which was 14% of Kit Carson Electric's overall load, all while fixed costs remain the same.

Kit Carson Electric wishes to sincerely thank our members for supporting your electric Cooperative through the rate case process. In the Cooperative model and spirit it is paramount that we continue to deliver safe, reliable electric service to all our members. KCECs service territory; which encompasses Taos, Rio Arriba and parts of Colfax County are extremely diverse and encompass some of the hardest terrain to serve in the state of NM. Kit Carson Electric will continue striving to provide the most reliable and robust quality of life services that members in rural Northern New Mexico are entitled to and have come to expect.

FIBER OPTIC SERVICES

Fiber Project Update

Kit Carson Telecom (KCT) has over 4,800 residential and small business customers connected to true high speed internet via fiber optics in nearly every territory serviced by KCEC, at speeds of 30Mbps or greater. KCT continues to add an average of 325-400 customers to fiber every month. This brings KCT's total network subscribership across all products to over 5,900 customers. KCT continues to enhance its network reliability and service offerings which will now include 24/7/365 U.S. based technical support and monitoring, carrier class phone service for residential and commercial customers via our partners at Star2Star, and we now offer residential and commercial security systems through our local partners at Security Systems of New Mexico. KCT will continue to look for the enhanced products and services that will greatly improve not only our product offerings but will continue to greatly improve the quality of life for our members. Our project has and continues to create an abundance of opportunities for our members. From greater access to Tele-Medicine and Tele-Health, online education opportunities to long term sustainable economic development opportunities through job creation in our region.

How many jobs were created?

Today, (KCT) has over 32 employees directly tied to the day to day operations of delivering broadband services and we continue to grow as we continue to expand our services offering. Nearly all in-house employees are local to the communities KCEC/KCT serves. Additionally, to date the project has created 405 jobs, 90% which have been local; which were tied to physical main line construction. It has also given our local contractors and their laborers the experience and the skillsets to bid, and obtain projects outside the KCT service territory. As broadband has become a major national focus to bridge the digital divide by telecom companies, other electric cooperatives, governmental entities, and communities in general, KCT's project will continue to enhance job creation on many levels, KCT is extremely proud that through this project we have had the ability to expose the talents through local labor force that existed right here within our community, and that those individuals, along with many more to come now have the opportunity to capitalize on opportunities available through this ever advancing technology. This endeavor has greatly added to the economic viability of our surrounding communities.

FIBER OPTIC SERVICES-continued

- Increased efficiency of Kit Carson Electric's system improving overall safe and reliable service



 KCEC/KCT now serves members with high speed services in the areas of Amalia, Costilla, Questa, Arroyo Hondo, Arroyo Seco, Taos, Penasco, Angel Fire, and Red River. The connection phase began with those entities that provide critical infrastructure services such as hospitals, municipal administrations, libraries, and public schools. KCEC/KCT is working diligently to insure that every member in the service area wishing to receive high speed connectivity through KCT will be connected.



Every year KCEC sponsors five high school Junior students from schools; whose parents or guardians live in our service area to participate in the youth tour. Each student submitted a 750 word essay on this subject;

"Describe the impact of Rural Cooperatives in a small community. How does Kit Carson impact your community?"

These students will be learning about electric cooperatives, American history and U.S. government on their trip. They will attend educational seminars and visit with their representatives in the House and the Senate. They will also visit historical sites in and around Washington D.C. and learn about the cooperative business models. CONGRATULATIONS!!
