AVAILABILITY:


Available to all grid-tied residential, seasonal, and small commercial consumers and individually metered apartments who require less than 50 kVa transformer capacity within the Utility's service area up to the amount of renewable resources available.

NET RATE PER BILLING PERIOD: (Or part thereof/service)

Alternating current, single phase, 60 Hertz at available secondary voltages. The rate for this service will be a renewable power premium (added charge) for all renewable power delivered to the participating customer. The renewable power shall be purchased in the form of 100 kWh blocks. The monthly premium for each 100 kWh block shall be the amount charged to utility by Tri-State Generation and Transmission, Inc. or any other supplier of renewable power being sold to the member. Utility shall file the applicable renewable power rate with the Commission monthly as part of its fuel and purchased power cost adjustment clause filing and shall be posted at the main office of the Utility and made available to all members upon request.

CONDITION OF SERVICE:


It is understood by the consumer that by opting to use the renewable rate the customer is making a minimum one-year commitment. A one-year contract will be required.
