Re: Formal Request to Lower Gasoline Prices in Northern New Mexico

Dear Honorable Governor Michelle Lujan Grisham and Honorable Attorney General Hector Balderas,

As you know, gasoline prices are lowering because of the COVID-19 health emergency and the global price of oil. In Northern New Mexico and the Enchanted Circle, gas prices remain high. As community leaders, we are deeply concerned with the impact this is having on our businesses, residents and employees. As New Mexicans are losing their jobs, having reduced work hours, closing their businesses, we need your offices to act to protect New Mexicans from unaffordable gasoline prices.

According to New Mexico Gas Prices, <a href="http://www.newmexicogasprices.com/">http://www.newmexicogasprices.com/</a>, all of our local gas stations have maintained high prices:

Sinclair at \$2.48

Smith's at \$2.45

Speedway and Phillips and at \$2.39

In other parts of the state, the lower prices range \$1.35 - \$1.49. The New Mexico Gas Prices website shows a dollar difference per gallon. Our people cannot afford an extra \$15 - \$25 each time they fill up their vehicles. Too many people are losing their jobs, being furloughed or are attempting to keep open small businesses.

We are requesting immediate assistance in your respective offices contacting the above-mentioned companies to lower their prices immediately and keep affordable gas prices during the COVID-19 crisis that is affecting all New Mexicans. If these companies decide not to cooperate then we request to please open an investigation into *price gouging* from Smith's, Sinclair, Speedway, and Phillips.

During these troubling and uncertain times and this terrible health and economic crisis, we as the State of New Mexico citizens and businesses all have to cooperate and work with each other and share in the sacrifices that all of us are having to face and we encourage your respective offices to encourage the above mentioned companies also to be a good corporate citizen and lower the gas prices to competitive and affordable prices.
