The 2020 Census is Coming Up!

New Mexico receives \$7 billion in Federal funding every year based on our Census numbers, and an undercount of just 1% of Taos County's population means a loss of \$9.7 million in federal funding for Taos County over the next decade.

Starting March 12th, you can complete your Census form online, by phone, or by mail. If your mail is delivered to your home, you will be receiving your Census questionnaire and instructions through the United States Postal Service. If you receive your mail at a P.O. Box, a Census Bureau representative will be dropping off your questionnaire and instructions at your home.

The Census includes 10 simple questions that are safe for everyone to answer. Your responses are private and protected by law. According to Title 13 of the U.S. Code, your data will not only be kept private, it cannot be used to identify you by any government agency or used against you in any court of law.

So remember, respond to the Census and make sure you count!
