(KCEC) was called to order by the President, Mr. Bobby Ortega, on Tuesday, August 25 2020 at 9:00 a.m. in the Marcelino Martinez Room of the headquarters building of the Cooperative, Taos, New Mexico. Mr. Martinez reported crew visits and meetings in morning with operations were being held. The President reported requests have been received from Estates in the amount of \$12,016.14. It was moved by Mr. Medina, seconded by Mr. Jassmann, and unanimously approved, that payments be made to these Estates.

Mr. Reyes reported the Broadband Committee met August 20, 2020. He reported Kit Carson Internet currently has 7,794 customers. He reported KCI was focusing on student connects, he stated 200 students had been connected. KCI continues to work with School

Broadband Committee Superintendents on installing additional hot spots. He reported 1,300 students had no internet service or adequate service. He reported Kit Carson Internet had three contractors assisting with internet connections. Next Broadband Committee meeting is scheduled for September 24, 2020 at 3:00 p.m.

Mr. Rodarte reported the Solar Committee met August 14, 2020. He reported KCEC should be getting the permit from the Town of Taos for the Taos Mesa Solar Project in September and construction will begin in April 2021. Mr. Reyes reported we are still lacking a permit for the Angel Fire Solar Project. Discussion was held. Next Solar Committee meeting was scheduled for September 9, 2020 at 9:00 a.m.

Mr. Reyes reported that a Virtual Strategic Planning Session with CoBank is scheduled for September 17, 2020 from 9:00 a.m. to 3:00 p.m. This would be a follow up to the Strategic Planning held at the September 25, 2019 at Taos Ski Valley.
