The Constitution of the United States requires that we count every person living in the country every 10 years. Census data is used to determine funding for important community services such as our schools, roads, and healthcare system, our emergency preparedness and response system, our

social service programs, and our safety net programs like WIC, Medicare, Medicaid and SNAP. For every single person in Taos County who gets counted in the 2020 Census, about \$50,000 will come into our county over the coming decade for all these important services and many more.

Because of the Covid 19 outbreak, the Census Bureau has not been able to deliver Census packets to many homes in Taos County. But you can still respond! If you go to the website or call the hotline listed below you can provide your physical address or a description of where you live even if you do not have the 12 digit code.

The Census includes 10 simple questions that are safe for everyone to answer. Your responses are private and protected by law. According to Title 13 of the U.S. Code, your data will not only be kept private, it cannot be used to identify you by any government agency or used against you in any court of law.

So remember, respond to the Census and make sure you count. Your community needs you!

> As a first step, we are working to identify 100 free Internet access points across Taos County to create a "safety net" for students and families in times when home access isn't an option or when there is a disruption for any reason. During COVID-19 and our move to remote learning, we found that a lot of Taos students had workarounds - like working at their grandparents' house or at a parent's place of business that didn't support them when those

places became unavailable. Others have struggled financially with the impacts of COVID-19 on the local economy and have lost access over the summer.

Area businesses and organizations pledge to allow Taos County students to access their Internet for the purposes of completing their schoolwork. Other early partners include Taos Ski Valley, Taos Municipal Schools, Taos Academy, Taos Integrated School of the Arts, UNM-Taos, and UNM - TECC. Together we can close the gap in learning continuity for Taos students!
