The President reported the reason for the Special Board Meeting was to review and approve the 2023 Budget.

Mr. Rodarte led the Board in reciting the Pledge of<br/>Allegiance.Pledge of<br/>AllegianceMr. B. Torres led the Board in a word of Prayer.PrayerIt was declared a quorum was present.Quorum

The agenda was presented. It was moved by Mr. Rodarte, Agenda seconded by Mr. Jassmann, and unanimously approved, that the agenda be approved as presented.

Mr. Shafto began with the presentation of the Accrual Review and Budget and Preliminary Financial and Statistical Ratios Approve 2023 for 2023. Purchase power and revenue projected flat. Budget Proposed budget does not include revenue for sale of

excess power. Department Managers gave a presentation of each department's mission, annual comparison, and goals for the 2023 Budget. Discussion was held on the mission and budget goals for each department. Mr. Martinez reported tree trimming and maintenance will be completed for high fire risk areas. Mr. Shafto stated that would be a non-revenue expenditure. Discussion was held on whether to consider utilizing another auditing firm. Mr. Shaft• stated KCEC is complex due to electric service, broadband service and propane service and is a specialized industry. Eide Bailly LLP is an auditing firm that was familiar with the specialized industry and would be rotating partners so different auditors would be completing the audit in 2023. The President recommended the approval of the 2023 Budget. Mr. Reyes stated Kit Carson Internet's request to charge a fee for credit cards may impact the 85/15 rule. He recommended that the rule be reviewed. Discussion was held regarding a new headquarters building. Mr. Reyes stated the building was remodeled to save money; however, need to consider a new office building. It was moved by Mr. D. Torres. seconded by Mr. Medina, and unanimously approved, that the 2023 Budget be approved as presented.

There being no further business to come before the Board, it was moved by Mr. Jassmann, seconded by Mr. B. Torres, and unanimously approved, that the Board of Trustees of Kit Carson Electric Cooperative, Inc. be adjourned until January 27, 2023, at 9:00 a.m. the date and time of the next Board meeting. Unless changed and, thereupon, the President declared the meeting adjourned at 10:40 a.m.
