## CEO'S Message

**KCEC Plans to Install Eight Additional Electric Vehicle Fast Chargers In Its Service Territory** 

Taos, New Mexico - Kit Carson Electric Cooperative, Inc (KCEC) announced that the New Mexico Department of Transportation (NMDOT) has selected KCEC to install eight additional EV fast charging stations in its service territory.

The NMDOT award for KCEC will provide funding for engineering services, design, and installation of electric vehicle (EV) DC fast charging stations across seven New Mexico locations under the NMDOT Level 3 Direct Current Electric Vehicle Charging Station Grant Program.

The charging station host entity and their respective locations are:

KCEC began establishing EV charging stations throughout its service area in 2019 as part of its plan to be among the cleanest, most cost-effective electric cooperatives in America. With the new charging sites, KCEC will have 44 total EV charging stations and expand its contribution toward New Mexico's statewide objective to reduce greenhouse gas emissions by 45% by the year 2030. The EV grant award is the latest in a string of 2022 milestones KCEC is meeting in partnership with its wholesale power provider, Guzman Energy, including having lower retail electricity rates than any Tri-State member cooperative, and achieving 100% daytime solar powered this year.

With these new charging stations, KCEC is providing our members with expanded clean energy economy services that improve quality of life and economic opportunity in our region. KCEC is thrilled that the NMDOT shares our vision to ensure EV services are available to our communities as well as to our valued New Mexico tourism visitors.
