CEO'S Message

Green Hydrogen Energy Production in **Ouesta**

In August of 2023, the U.S. Department of Energy released its Intermediate Feasibility Study results regarding the production of clean hydrogen energy in Questa, NM.

The Communities Local Energy Action Program (LEAP) pilot provides tailored research and analysis services to communities that are low-income, energyburdened, experiencing environmental justice impacts, or experiencing a shift away from economic reliance on fossil fuels.

In Questa lies Chevron's molybdenum mine, which shuttered its operations in 2014, creating substantial job losses in the region. Presently, the mine is undergoing an extensive environmental rehabilitation process, a journey projected to extend well into the 2040s.

Community leaders, together with experts in the field of renewable energy, have been exploring the feasibility of establishing a green hydrogen production facility in Questa, NM. KCEC is also exploring green hydrogen and other renewable alternatives to meet its membership-driven and State of NM 100% renewable energy goals.

This project examines two end uses that are challenging to decarbonize:

- Electricity demand when there is little sunshine and wind
- Off-road vehicle transportation.

Batteries can partially meet these end uses with high energy efficiency but at limited scale (timescale of hours). Like batteries, hydrogen is a carbon-free energy carrier, but unlike batteries, it can be stored at scale (days to months timescale). This scaling is key for: electricity demand during prolonged periods of low wind and sun resource.

Integrating batteries and hydrogen systems with clean energy generation can provide short and long duration storage across multiple scales of energy needs.


